A small group of Children's Hospital Medical Center of Akron (CHMCA) Trustees met early in 1971 to assess the long-term needs of the institution and those it served They foresaw an unprecedented period of change and growth ahead, caused by the burgeoning advances in medical science as well as the expanding multi-county area served by CHMCA They predicted that, to fulfill the health needs of the coming generation, CHMCA would have to undergo a drastic change, moving from primarily a community facility to a major regional medical center At the same time, they realized that this growth could not be financed from patient fees alone On June 3, 1971, they formally established the Akron Children's Hospital Foundation, a separate, not-for-profit corporation, to secure funds which would "add breath and depth to CHMCA's capabilities in health care, medical research and education " During 2013, CHMCA launched a \$200 million expansion project of it's Akron hospital campus to meet the current and future needs of children and their families This expansion project included the building of a new neonatal intensive care unit, a new emergency department, dedicated outpatient surgical suites and dedicated space for several of the hospital's pediatric subspecialty programs Called the "Building on the Promise," the expansion project was a result of significant growth in the hospital's patient volumes and services Philanthropy played a key role in the success of the campus expansion The Akron Children's Hospital Foundation oversaw the Building on the Promise Campaign and set out to raise \$50 million Over and above the \$50 million dollar campaign, \$6,250,000 unrestricted Foundation funds were used for the capital project during 2014 Also during 2014, \$6,816,478 Foundation funds were used by CHMCA to support its mission Of that amount, \$2,520,000 was provided by the Foundation for CHMCA's program operating expenses at the Akron and Mahoning Valley locations that would not have otherwise been available through the annual budget Additional support also went for the following programs \$1,114,615 Hematology/Oncology, \$390,372 Community Youth Fitness, \$287,000 Adoption Center, \$218,740 Global Health, \$208,471 Regional Burn Center, \$200,804 Reach Out and Read Program, \$187,530 Palliative Care, and \$52,375 Autism Family Child Learning Center The remaining amount was used for research, training, education and support programs including Neonatal, Pediatrics, Child Advocacy, and other programs Since the Foundation's creation, it has provided the sources to purchase specialized lifesaving medical equipment which might not have otherwise been possible within the Hospital's budget limitations The Foundation has financed medical research into cause, prevention and treatment of complex childhood diseases and problems, and has provided community safety programs in professional education, patient information and youth development The net effect of these efforts has been to keep CHCMA at the forefront of healthcare, while minimizing the cost of such care to patients and their families

It is the responsibility of the President or his designee to evaluate any circumstance in which a duality of interest exists, (if known, when disclosed or undisclosed), to determine whether the duality represents the potential for a conflict of interest, and whether such conflict is so substantial that it is deemed to be detrimental to CHMCA. Any employee who is directly or indirectly involved in a situation which represents a duality of interest, and as such, a potential conflict of interest, will abide by the following policies: 1. Individual will not be permitted access to any information which may provide an unfair advantage to that individual or the firm he/she represents. 2. Individual will be required to withdraw from any meeting in which the matter is discussed. 3. Individual will not be permitted to participate in deliberation or vote on the matter and will be required to leave the room during voting. 4. Any employee is expressly prohibited from releasing any "sensitive information" regarding a decision made or being considered to any person who may have a duality of interest, and as such, a potential conflict of interest. 5. Any attempt on the part of any employee to unfairly influence or impact the decision making process in favor of personal interest may be considered breach of trust and may be cause for removal from his/her position of responsibility or other disciplinary action up to and including discharge.

Key Committee responsibilities include: - Ensure executive total compensation is appropriate in light of the CHMCA's mission and values, and - Approve an executive compensation philosophy, the associated programs, and all compensation actions for individual executives. The Committee is comprised of independent members of the Board of Directors who have no personal interest in any executive compensation transaction. - Should a potential conflict of interest be identified, the Committee determines the extent of the conflict and the means to address it. - In certain cases, a Committee member may be asked not to participate in discussions of, or vote on, a particular compensation transaction. The Committee governs CHMCA's executive total compensation for all senior executives who are deemed to be disqualified persons. The Committee also governs the total compensation of other disqualified persons, e.g., family members of board members or executives who are employed by CHMCA. The Committee follows all steps required by the Internal Revenue Service to qualify for the safe harbor under the Intermediate Sanctions regulations. The Committee: 1) Reviews compensation data for comparable positions at similar organizations which are compiled by an independent consultant it engages, 2) Uses this data to make executive decisions, and 3) Documents its compensation deliberations and decisions in a timely manner. The Committee reviews appropriate sections of CHMCA's IRS Form 990 before it is filed to ensure accuracy and completeness. An independent salary survey was completed in 2014 and recommendations were provided and presented by the independent consultant to the compensation committee for approval.
