PROCEDURES

CAPITALIZATION POLICY

THE TERM "CAPITALIZATION" MEANS THAT A COST SHALL NOT BE EXPENSED DURING THE CURRENT PERIOD, BUT INSTEAD WILL BE CLASSIFIED AS APPROPRIATE IN AN ASSET ACCOUNT, SUCH AS EQUIPMENT, FURNITURE, BUILDING COST, INVENTORY, OR PREPAID EXPENSE. THE COMPANY SHALL ATTEMPT TO COMPLY WITH THE PROVISION OF IRS TD 9636. THE COMPANY DOES NOT HAVE AUDITED FINANCIAL STATEMENTS, OR OTHER FINANCIAL STATEMENTS THAT COMPLY WITHIN THE MEANING OF "AFS" PER THE IRS.

ACCORDINGLY, ALL ITEMS WHICH ARE NOT INCIDENTAL MATERIALS AND SUPPLIES SHALL BE SUBJECT TO THIS POLICY.

ROUTINE MAINTENANCE IS EXPENSED, UNLESS IT IS ANTICIPATED TO OCCUR LESS THAN ONCE DURING THE DEPRECIATION CLASS (OR IN THE CASE OF BUILDINGS AND COMPONENTS, LESS THAN ONCE EVERY TEN YEARS).

BETTERMENTS ARE CAPITALIZED. ANY EXPENDITURE WHICH AMELIORATES A MATERIAL CONDITION OR DEFECT, RESULTS IN AN ADDITION, OR INCREASES CAPACITY, PRODUCTIVITY, ETC. IS A BETTERMENT.
