Eschaton Foundation has a conflict of interest statement that Board members must complete and submit annually. The Eschaton Board approves all salaries and compensation paid to Foundation Directors and Board members

One Board member is compensated for his programmatic duties and not his Board duties.

The Form 990 is reviewed by key Board members and by the whole Board at the Annual Meeting.

Other Program Services include other programs of the Resource Center for Nonviolence which include programs for nonviolence and racial awareness. Eschaton Foundation itself has a modest granting process and scholarship program. Eschaton's fiscal records, Form 990 and schedules, and Conflict of Interest Statement are available to the public upon request.

Form 990. Part VIII, Line 7c - In 2004 the organization received a property as a donation. The value of the property was greatly over estimated and its value decreased more during the recession of 2009. We listed the property in 2014 but received no offers close to its assessed value. The price was lowered until a buyer was found. Eschaton received \$281,530 (which includes \$26,434 in expenses).

Form 990. Part XI, Line 9. Line 9 is composed of \$163,175 which is a Construction in Progress project the Foundation has abandoned. During 2007 and 2008 the Foundation worked with another non-profit to remodel an existing building to serve as an enhanced facility that would meet both agencies' needs. Unfortunately the project was abandoned for various reasons before the actual construction phase was begun. The \$163,175 reflects the Foundation's share of soft costs. There were two primary reasons the project was abandoned: 1.) the project was to be financed in part by the sale of condominiums built on the property. It became obvious that the condominium market had dropped dramatically in sale price and over-availability, and, 2.) after a period of fundraising it was apparent that the funds needed to complete the project were not attainable at that time.
