	Health Education -The Annex Teen Clinic provided health education and outreach presentations to 14,103 individuals in 2014. This represents unique or unduplicated individuals. Of the 14,103 youth served 98% demonstrated an increased knowledge about pregnancy prevention, STI and HIV prevention and/or misconceptions they had about the topics were corrected.

Clinic -The Annex Teen Clinic provided confidential, sexuality related clinical services to 1581 adolescents and young adults in 2014. These clinic patients were seen for a total of 3,543 visits. 100% of all clinic patients were screened for sexually transmitted infections and 100% of those testing positive were treated. 96% of those clinic patients seen for birth control/contraceptive services were compliant with their chosen method and did not experience an unintended pregnancy.
