ECAS sponsors and teaches Birding for Pre-Schoolers, Fledgling Fun for grade school students, and Young Birders of Central Oregon for older students. The student programs focus on bird behavior and biology, and include outdoor birding trips. ECAS also provides speakers for schools on subjects pertaining to birds. The Program benefits more than 500 students annually.

Form 990EZ, Part III, Line 30, Adult Education Programs: \$3209

ECAS sponsors Birders' Night, a monthly meeting that includes discussion of upcoming events and recent unusual bird sightings and a presentation by a speaker on birds, birding and/or conservation relating to birds. The event is free and open to nonmembers as well as members. Forty to fifty people attend each meeting.

ECAS also sponsors the Dean Hale Woodpecker Festival, an annual 4-day event offering field trips to areas in central Oregon, focusing especially on the region's 11 species of woodpeckers. More than 100 birders attend the festival.

ECAS conducts weekly bird walks and field trips that are free to members and nonmembers. It also maintains a Facebook page to share photos and birding information, and circulates a monthly bulletin (The Chatter) and quarterly newsletter (Calliope) to

ECAS has amended its Bylaws as follows: (1) to clarify the delegation of checkwriting authority in the absence of the Treasurer, and
permit any officer to provide the second signature for checks for more than \$500, (2) to provide that the Executive Committee may
authorize expenditures in excess of budgeted amounts, establish a \$3000 limit on such expenditures, and clarify that all Executive
Committee actions are reportable to the board, (3) to clarify that unanimous consent is required in the event of Board action without
a meeting, and (4) to provide that the President is not automatically a member of all committees, but may appoint him or herself to any
committee. The purpose of these amendments was to address ambiguities.
