**EDUCATION**-Information related to Natchez regional history, genealogy, architecture, and decorative arts is provided on a daily basis to local citizens, governmental and other organizations, visitors, scholars, writers, genealogists, historical associations, museums, filmmakers, and others. The staff lectures about Natchez, general history, historic preservation, architecture, landscape, gardens, and decorative arts to local citizens, local and visiting organizations, and to tourists from out of town. The staff arranges visits and the Foundation opens its headquarters five days a week, on weekends with special programming, or by request The Foundation also displays exhibits related to the themes previously cited. The Foundation operates a reproduction licensing program, which raises public awareness of the historical significance of Natchez and provides impetus for cataloging the city's decorative arts. In 2014, staff members continued to invest time in writing text and providing images to the City of Natchez for a "Museum of the Streets" project which began in 2009 in conjunction with a walking trails project. The Foundation also allows other non-profit organizations and governmental entities to use the facilities at the Foundation's headquarters in the Natchez Institute at no charge for meetings and educational programming.

**PRESERVATION**-The Foundation works to preserve endangered buildings and sometimes acquires properties and places easements on the property before re-sale. In some instances, the Foundation undertakes stabilization or restoration work before re-selling the property The Foundation owned four historic properties at the beginning and end of 2014 The Foundation administers two funds dedicated to preservation and restoration activities--the Masterson Fund and the Whatley Fund. The Foundation serves in an advisory capacity to the Natchez Preservation Commission and works with the city to insure that public and private projects meet historic preservation guidelines. On a daily basis, the Foundation advises and assists architects, contractors, developers, craftsmen, organizations, and the general public on proper preservation and restoration methodology and on the design of new buildings to make them compatible within a historic context. The Foundation also assists citizens, accountants, lawyers, bankers, and developers on local, state, and federal issues and benefits related to the acquisition, development, and ownership of historic properties

**COLLECTIONS**-(Foundation Archives, Artifacts, and Public Records)-The Foundation has a significant collection of important archival material, museum artifacts, and public records related to the history of the Natchez region. The Foundation's collections include books, photographs, documents, site files, subject files, artifacts, and public courthouse records. The archives and public records are made available on a daily basis to the public under the supervision of the Foundation staff The Foundation maintains a research library with books and reference material on Natchez and regional history, Mississippi history, historic preservation, architecture, and decorative arts The Adams County Board of Supervisors has entrusted the Foundation with the care and management of public courthouse records dating to the 18th, 19th, and 20th centuries The county began locating circuit court records to the Foundation headquarters in 1992, and the program expanded in 2008 to include Chancery Court records The county provides a small amount of funding for records management The Foundation has sponsored a program in conjunction with universities and the National Park Service to preserve and catalogue these valuable historic documents Staff members continually process the courthouse records to preserve them and to build a comprehensive computer database to make them more accessible to the public

The Historic Natchez Foundation has a grants fund established in 2001 by a donation specified for that specific purpose by the late Floyce T. Masterson. This fund is limited to grants or loans for the preservation and restoration of buildings, landscapes or landscape features (fences, fountains, gazebos, etc.) and is further limited geographically to Natchez and Adams County. Since all projects are local, the professional staff of the Historic Natchez Foundation can easily monitor the work. In 2014, the foundation awarded a \$5,000 grant to the City of Natchez which requested funding assistance for restoration work in historic Memorial Park, established in 1890. The professional staff of the foundation was involved in the planning and execution of the restoration of herring-bone brick walks.

The Historic Natchez Foundation occasionally receives designated gifts for preservation and restoration work on specified historic properties, including historic cemeteries and churches. In 2014, the Historic Natchez Foundation transferred \$2,700 in donated funds specified for the preservation and restoration of Christ Episcopal Church built in 1858. The professional staff of the foundation made a site visit to the church to inspect the building and to document problems by making a photographic record. One pew had split and needed repair, the front door lock had been stolen, the roof had a few leaks, and bats had found a way into the building. The \$2,700 was applied to the cost of making needed repairs.
