Tenant Worker Center (TWC): This program empower workers through education and organizing to recover over \$4 million this year in stolen wages, in partnership with Asian Law Caucus, DLSE, OLSE-including the major Yank Sing settlement victory. In one particular restaurant case, we helped over 90 workers file wage claims at one restaurant as well as educated the employer on labor laws and reform its labor practices.

Youth Organizing: This program strives to develop youth's leadership skills through their participation in our campaign work. This year, over 60 youth participated. We completed our 4rd annual Youth Leadership Retreat, where 35 attended to learn about CPA's history and campaigns, and to build community with each other. During the summer, Youth members focused on building learning about the issues facing minimum wage workers and about increasing rental costs in San Francisco. In total, we collected almost 800 signed postcards from residents who support making San Francisco more affordable and jobs better paying.
