Members attending the Annual Corporate Meeting elect three Board members to fill three 3-year terms; additionally, they elect Board members as necessary to fill any open unexpired 3-year terms (if any open positions exist at that time)

Form 990, Part VI, Section B, Line 11B - The Form 990 is prepared by the Treasurer of the Corporation. The prepared return is provided to the members of the Board of Directors at a regularly scheduled meeting for their review either prior to submission, or directly thereafter. The completed form is also reviewed by the Corporate Audit Committee during their Annual Audit of the Corporate books and records.

Form 990, Part VI, Section C, Line 19 - All financial statements and governing documents are made available upon specific request and subsequent approval of the Board of Directors. Financial results and plans are presented in detail by the Treasurer at the Annual Corporate meeting.

Form 990, Part XII, Line 2C - Corporate By-Laws provide for an Audit Committee consisting of three members of the Board of Directors. Positions on the Audit Committee are filled annually on a rotating basis to ensure independence and objectivity.
