PROVIDED BONE DONATIONS THAT COULD BE USED TO REPAIR A DAMAGED LIMB AND POSSIBLY SAVE IT FROM AMPUTATION, EYE DONATION GIFTS THAT COULD BE USED TO RESTORE VISION, AND COUNTLESS OTHER TISSUE RECOVERIES THAT WILL GREATLY IMPROVE THE LIVES OF THOUSANDS OF TISSUE RECIPIENTS IN 2014, MTS CONTINUED TO MAINTAIN THE SIGNIFICANT IMPROVEMENTS MADE TO ITS CUSTOM-BUILT FACILITY TO BETTER SERVE DONOR FAMILIES, DONATION PROCESS, ONGOING ASSISTANCE FOR HOSPITALS WITH COMPLIANCE WITH STATE AND FEDERAL REGULATIONS, DONATION POLICIES WITHIN THEIR INSTITUTIONS, AND ANALYSIS OF QUANTITATIVE AND QUALITATIVE OPTION TO DONATE COMMUNICATION AND COLLABORATION IN 2014 RESULTED IN 8 OUT OF 10 MTS HOSPITAL PARTNERS RATING THEIR SATISFACTION WITH THE ORGANIZATION AS 10 OUT OF 10 MTS COORDINATORS FROM THE FAMILY SUPPORT SERVICES AND DONOR SERVICES DEPARTMENTS WORK WITH FAMILIES AT THE TIME OF THEIR LOVED ONE'S DEATH, OFFERING EDUCATION, INFORMATION AND SUPPORT DURING THEIR DECISION-MAKING PROCESS FOLLOWING PEOPLE AT 3 CANDLELIGHT MEMORIAL CEREMONIES, WHICH FEATURED INSPIRATIONAL STORIES FROM TRANSPLANT RECIPIENTS AND A DONOR PHOTO TRIBUTE, PROVIDED RECIPIENT UPDATE INFORMATION TO 211 FAMILIES, HOSTED A PRIVATE SOCIAL MEDIA GROUP WITH OVER 172 MEMBERS THAT SERVED AS A VIRTUAL SUPPORT GROUP, IN HONOR OF THOSE WHO GENEROUSLY DONATE THEIR ORGANS OR TISSUE, MTS PRESENTS ALL DONOR FAMILIES WITH A GIFT OF LIFE DONOR MEDAL WITHIN A FEW DAYS OF THE DONATION AS A WAY TO PROVIDE ONGOING SUPPORT TO DONOR FAMILIES, MTS OFFERS THE GRIEF COMPANION PROGRAM THIS UNIQUE PROGRAM PROMOTES AND FOSTERS THE HEALING PROCESS AFTER A LOSS BY PROVIDING A COMPANION FOR INDIVIDUALS EXPERIENCING AND NEEDING SUPPORT FOR A RECENT LOSS IN THEIR LIVES IN 2014, THE PROGRAM HAD 26 ACTIVE GRIEF COMPANIONS A STRONG FOCUS ON
