The spending policy for this fund will be an annual distribution to Peters Family YMCA Camp Glacier Hollow in the amount of up to 4% of a 12 quarter rolling average of fund assets. This annual distribution will help provide an experience of a lifetime for children of all ages as well as necessary upgrades and camp improvements.

The YMCA Camp Fund will begin making distributions once the fund balances reaches \$100,000.

In 2014, \$5,037 was distributed from the YMCA Annual Campaign Trust Fund to the YMCA Annual Campaign. It was one of many vital gifts that allowed 4,247 individuals to experience the positive effects of our YMCA programs and activities.

In 2014, \$12,028 was distributed from the YMCA Program Enhancement Trust Fund. These enhancements greatly improved the overall experience YMCA members and participants.

\$4,000 was allocated the YMCA Diabetes Prevention Program that provides a supportive environment where participants work together in small group to learn about healthier eating and increasing their physical activity in order to reduce their risk for developing diabetes.
