The Organization primarily collects blood and blood products from voluntary donors. These products are processed and distributed to various public and private hospitals. The Organization collected 70,734 units of red blood cells and apheresis platelets from volunteer blood donors and prepared 84,111 transfusable components and 35,984 salvage products for remanufacturing from these collections of voluntary donors in 2014. The Organization distributed 93,063 transfusable blood components to public and private hospitals within the State of Mississippi and the surrounding states. The Organization made monetary contributions of \$16,375 to other non-profit organizations and provided an educational lecture and facility tour to 45 students from Canton Academy. The Organization provided 328 blood pressure and hematocrit checks free of charge to area residents who are unable to donate blood. One member of management volunteered for two days at the MS Sickle Cell Foundation Annual Camp. The Medical Director and others provided blood bank training to 44 medical technology students from the University School of Medicine and 3 other area hospitals. The Organization performed 551 therapeutic procedures free of charge for members of the community who have been diagnosed with polycythemia vera. The Manager of Hospital Relations hosted 10 blood transfusions related meetings for laboratory staff from area hospitals. The Organization donated 32 used computers and printers to Jackson State University for training purposes and donated 201 purple top tubes to University of Mississippi Medical Center to collect bone marrow samples.
