THE INTERNATIONAL SOCIETY OF AUTOMATION (ISA) IS A PROFESSIONAL ASSOCIATION THAT SETS THE STANDARD FOR THOSE WHO APPLY ENGINEERING AND TECHNOLOGY TO IMPROVE THE MANAGEMENT, SAFETY, AND CYBERSECURITY OF MODERN AUTOMATION AND CONTROL SYSTEMS USED ACROSS INDUSTRY AND CRITICAL INFRASTRUCTURE. FOUNDED IN 1945, ISA DEVELOPS WIDELY USED GLOBAL STANDARDS, CERTIFIES INDUSTRY PROFESSIONALS, PROVIDES EDUCATION AND TRAINING, PUBLISHES BOOKS AND TECHNICAL ARTICLES, HOSTS CONFERENCES AND EXHIBITS, AND PROVIDES NETWORKING AND CAREER DEVELOPMENT PROGRAMS FOR ITS 36,000 MEMBERS AND 350,000 CUSTOMERS AROUND THE WORLD.

TRAINING IS OFFERED AT THE SOCIETY'S HEADQUARTERS FACILITY, AT SITES THROUGHOUT THE WORLD, IN-PLANT, AND DISTANCE LEARNING THROUGH INTERNET OFFERINGS. VIDEOTAPE AND DVD TRAINING PRODUCTS ARE ALSO SOLD BY THE SOCIETY. THE SOCIETY FURTHER MAINTAINS TWO PROFESSIONAL CERTIFICATION PROGRAMS, CERTIFIED CONTROL SYSTEM TECHNICIAN (CCST) AND CERTIFIED AUTOMATION PROFESSIONAL (CAP). BOTH WITH TRAINING AND TESTING OFFERED. THE SOCIETY DERIVES REVENUE FROM TRAINING SERVICES BY CHARGING PARTICIPANTS REGISTRATION FEES. (CONTINUED ON SCHEDULE O) IN 2014, 402 TRAINING COURSES WERE CONDUCTED AND THESE COURSES WERE ATTENDED BY 2,386 INDIVIDUALS. ISA ALSO DERIVED REVENUE FROM ISSUING CERTIFICATIONS BY CHARGING PARTICIPANTS FEES FOR APPLICATIONS AND RENEWALS. IN 2014 THE CERTIFICATION (CCST + CAP) TOTAL OF NEW APPLICATIONS WERE 341 AND THE RENEWALS WERE 1,685.
