Summary Activity Report

April 2014-March 2015

The Sunil and Nita Wadhwani Foundation (USA) is the Founding Donor to Lord Education and Health Society for implementing Wadhwani Initiative for Sustainable Healthcare in India. During the period April 2014-September 2015 some of the key strategic activities were supported by the Foundation are listed below.

1. Development of a five year strategy plan for WISH towards transforming primary healthcare delivery system through innovations in priority states of Rajasthan, Madhya Pradesh and Odisha. (June 2014)
2. Supported the Millennium Alliance with an annual grant of \$ 30,000 to support innovations in healthcare. The alliance under Federation of Indian Chamber of Commerce has partners such as the United States Agency for International Development (USAID) and the Technology Development Board (TDB), etc. (April 2014-March 2015)
3. Healthcare Partner to Sankalp Forum 2014. Awarded iKure with \$ 20,000 grant for the most promising inclusive model in April 2014.
4. Development of an open source database of 165 Inclusive Business Models of Healthcare in India in partnership with World Bank, International Finance Corporation (September 2014). Total Funding was \$ 60,000.
5. Development of a database of 281 public sector innovations in India through a high level Advisory Group comprising of government, civil society and private partners. (March 2015) Total Funding will be \$ 12,000
6. Organizing a national SCALE Healthcare Innovations Summit in November 2014 to launch WISH Foundation and build a healthcare ecosystem to scale up innovations for primary healthcare. Total Funding was about \$ 50,000
7. Conceptualized and launched the SCALE Program a strategic mechanism to scale up promising healthcare innovations that intends to impact the access and availability of quality and affordable primary healthcare at the last mile. The program with an investment of USD 50 mn over five years to make 300 critical Primary Health Centers (PHCs) and attached sub-centres (SCs) in 3 states of Rajasthan, Madhya Pradesh and Odisha deliver high quality healthcare services efficiently and cost effectively with special emphasis on Reproductive Maternal Neonatal Child Health and Adolescent health. The program will leverage grants and funds from donors, Corporates and International AID Agencies.
8. Signed a five year Memorandum of Understanding with Department of Medical Health and Family Welfare, Government of Rajasthan (February2, 2015) to scale up healthcare innovations and bring in greater engagement between public and private sector to strengthen the primary healthcare and improve access to quality and affordable healthcare.
