Bylaws

Approved by the Finance/Internal Affairs Committee: 1.12.15

I. Corporation Offices

- 1.1 **Principal Office.** The principle office of the Corporation shall be located in Big Timber, Montana. The Corporation may have such other offices as the Board of Directors may determine from time to time.
- 1.2 **Registered Office.** The registered office of the Corporation required by the Montana Nonprofit Corporation Act to be maintained in the State of Montana may be, but need not be, identical with the principal office in the State of Montana, and the address of the registered office and registered agent may be changed from time to time by the Board of Directors.

II. Tax Status

- 2.1 The Corporation shall be operated as a 501(c) 3 tax-exempt corporation as defined by the Internal Revenue Code.
- 2.2 No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporations shall not participate in, or intervene in political campaign of behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the Corporations shall not engage in any activities or exercise any powers that are not in the furtherance of the purposes of the Corporation.

III. Purpose

- 3.1 The Corporation shall be organized exclusively for charitable purposes as a nonprofit corporation to cultivate generosity, simplify giving, build endowments, and distribute funds to benefit the community, and its activities shall be conducted for those purposes in such a manner that no part of the income or property of the Corporation shall inure to the benefit of any non-charitable member, or any director, officer, or individual.
- 3.2 The Corporation shall solicit, accept, hold, administer, invest, and disburse for charitable purposes such sums as may be given to it by any person, persons, corporation, foundation, or government entities.
- 3.3 The Corporation shall not substantially engage in any activity not permitted to be carried on by a corporation exempt from federal income tax under Section 501 (c) 3 of the Internal Revenue Code of 1986, as amended, or successor provisions.

IV. Membership

This Corporation shall not have members, as per our Articles of Incorporation.

V. Board of Directors

- 5.1 **Management by Board of Directors.** Except as otherwise provided by law, the Articles of Incorporation, or by these Bylaws, the business and affairs of the Corporation shall be managed by its Board of Directors (hereinafter "Directors").
- 5.2 **Number, Tenure and Qualifications of Directors.** The number of Directors of the Corporation shall not be less than three (3) and no more than twenty (20). The Board of Directors of the Corporation shall elect all Directors for three (3) year terms. Directors must be of legal age.
- 5.3 **Regular Meetings.** A regular meeting of the Board of Directors shall be held without other notice than this bylaw at the principal office of the Corporation or such other place designated by the Board of Directors.
- 5.4 **Special Meetings.** The board chair, the Executive Director, or any two members of the board may call special meetings of the Board of Directors.
- 5.5 **Notice of Special Meetings.** Notice of any special meeting shall be given by telephone, written, fax, or email at least two (2) days in advance. No other business shall be transacted at special meetings except such as is stated in the notification. If mailed, such notice shall be deemed to be given when deposited in the United States mail so addressed, with postage thereon prepaid. Any director may waive notice of any meeting. The attendance of a Director at a meeting shall constitute a waiver of notice of such meeting, except when a director attends a meeting for the express purpose of objecting to the transaction of any business because the meeting is not lawfully called or convened.
- 5.6 **Waiver of Notice of Meetings.** Whenever any notice is required to be given to any director of the Corporation under the provisions of these bylaws or under the provisions of the articles of incorporation or under the provisions of the Montana Nonprofit Corporation Act, a waiver thereof in writing, signed by the person or persons entitled to such notice, whether before or after the time stated therein, shall be deemed equivalent to the giving of such notice.
- 5.7 **Written Resolution by Directors.** Any action required or permitted to be taken at a meeting of Directors may be taken without a meeting if consent in writing, setting forth the action to be taken, shall be signed by all of the Directors entitled to vote with respect to the subject matter thereof. Such consent shall have the same effect as a unanimous vote.
- 5.8 **Quorum.** A majority of the elected Directors attending shall constitute a quorum for the transaction of business at any meeting of the Board of Directors. A majority

of the Directors present at the time and place of any regular or special meeting, although less than a quorum may adjourn the same without notice, until a quorum shall be present.

- 5.9 **Manner of Acting.** The act of the majority of the Directors present at the meeting at which a quorum is present shall be the act of the Board of Directors. Each Director shall have one vote. Directors shall not vote or sign Directors' resolutions by proxy. Directors may participate in meetings and act by way of telephone conference if such can be arranged so that all Directors can hear all other members.
- 5.10 **Vacancies.** Any vacancy occurring in the Board of Directors and any directorship to be filled because of an increase in the number of Directors shall be recommended by an affirmative vote of the majority of the Corporation's Board of Directors. A reduction in the authorized number of Directors shall not serve to disenfranchise any Director prior to the expiration of the term for which he/she was elected.
- 5.11 **Compensation.** Directors shall not receive compensation for serving on the Board of Directors. By authorization of the Board of Directors, Directors may be reimbursed for expenses incurred on behalf of the Corporation.
- 5.12 **Presumption of Assent.** A Director of the Corporation who is present at a meeting of the Board of Directors at which action on any corporate matter is taken shall be presumed to have assented to the action taken unless his dissent shall be entered in the minutes of the meeting. Such right to dissent shall not apply to a Director who voted in favor of such action.
- 5.13 **Resignation and Removal.** Any Director may resign at any time by submitting written notice to the Board Chair. Unless otherwise specified in such written notice, such resignation shall take effect upon receipt thereof by the Board Chair and the acceptance of such resignation shall not be necessary to make it effective. Any member of the Board of Directors of the Corporation may be removed due to three (3) consecutive absences from the Board of Directors' meetings or without cause by a two-thirds (2/3) affirmative vote of the Board.
- 5.14 **Standing Committees.** The Board of Directors may appoint Standing Committees. Such committees shall have the power to act between meetings of the Board and all committee activities shall be subject to approval of the Board. Standing committees shall have agendas for meetings and shall submit minutes of meetings to the Board. The Corporation's Executive Director shall serve on all committees. A member of the Board shall be appointed as the committee chairperson. The committee chairperson shall, in collaboration with committee members and staff, plan and oversee the work of the committee. Membership on standing committees shall not be limited to Directors, excepting the Finance Committee, which shall be comprised solely of Directors. No committee shall incur expenditures without the board's approval.
- 5.15 **Special or Ad Hoc Committees.** The Board may appoint a special or ad hoc committee for a limited time and/or a specific purpose, to be defined by the Board.

Special or ad hoc committees shall have agendas for meetings and shall submit Minutes of meetings to the Board. The Corporation's Executive Director shall serve on all committees. At least one director shall be a member of each the special or ad hoc committees. The committee chairperson shall, in collaboration with committee members and staff, plan and oversee the work of the committee. Membership on special and ad hoc committees shall not be limited to Directors.

- 5.16 **Executive Committee.** The Executive Committee shall consist of the Chair, Vice Chair, and Treasurer. The Executive Committee is authorized to transact the business of the Board of Directors in the interim between meetings of the Board, and shall present all records and actions to the board for ratification at its next meeting.
- 5.17 **Conflict of Interest.** The board shall adopt, periodically review, and monitor a conflict of interest policy to protect the Corporation's interest when it is contemplating any transaction or arrangement that may benefit any Director, officer, employee, or member of a committee with Board delegated powers.
- 5.18 **Dissolution.** Upon the dissolution of the Corporation, assets shall be distributed for one or more exempt purposes with the meaning of section 501 (c) 3 of the Internal Revenue Code, or the corresponding section of any future federal tax code. A Court of Competent Jurisdiction of the county in which the principal office of the Corporation is located, exclusively for such purposes, or to such organizations shall dispose of any such assets not so disposed, as said Court shall determine which are operated exclusively for such purposes.
- 5.19 **Liability.** No Director shall be liable for any debt, obligation, or liability of the corporation.

VI. Officers

- 6.1 **Required and Permissible Officers.** The officers of the Corporation shall include the Board Chairperson, Vice Chairperson, Secretary, and Treasurer. The same persons, except the offices of Chairperson and Secretary, may hold any two (2) or more offices. Such other officers as may be deemed necessary may be elected or appointed by the Board of Directors. The Corporation's Executive Director shall serve as an ex-officio member of all committees.
- 6.2 **Election and Term of Office.** The Board of Directors shall be given the opportunity to add names to the slate and the Directors shall duly elect officers of the Corporation annually. Each officer shall hold office for one year or until his successor shall have been duly elected and shall have qualified or until his/her death or until he/she shall resign or shall have been removed in the manner hereinafter provided. The officers shall have such duties, in addition to those expressed herein, as the Board of Directors shall specify from time to time.
- 6.3 **Removal.** Any officer or agent elected or appointed by the Board of Directors may be removed by the Board of Directors whenever in its judgment the best interests of the Corporation would be served thereby, but such removal shall be without

prejudice and shall require a two-thirds (2/3) majority vote of all members of the Board of the Corporation.

- 6.4 **Vacancies.** A vacancy in any office because of death, resignation, removal, disqualification or otherwise, may be filled by the Board of Directors for the unexpired portion of the term.
- 6.5 **Chairperson of the Board of Directors.** The Chairperson of the Board of Directors shall preside at all meetings of the Directors. He/she shall perform all the duties commonly incident to this office and such other duties, as the Board of Directors shall designate.
- 6.6 **Vice Chairperson.** The Vice Chairperson, in the absence of the Chairperson, or in the event of his/her death, inability or refusal to act, shall perform the duties of the Chairperson, and when so acting, shall have all of the power of and be subject to all of the restrictions upon the Chairperson. He/she shall perform all the duties commonly incident to this office and such other duties, as the Board of Directors shall designate.
- 6.7 **Secretary.** The secretary shall be custodian for the Corporation's records, and in general perform all duties incident to the office of secretary and such other duties as from time to time may be assigned to him or her by the Chairperson.
- 6.8 **Treasurer.** The treasurer shall have charge, be in custody of, and be responsible for all funds of the Foundation, and shall perform all duties commonly incident to the office of Treasurer and such other duties as may from time to time be assigned to him or her by the Chairperson.

VII. Contracts, Loans, Checks and Deposits

- 7.1 **Contracts.** Contracts exceeding the Executive Directors authorized expenditure limitations, or board officer or agent (with operation authority) is to be recorded in the Board Minutes reflecting the motion, vote and financial limitation before the contracts can be executed.
- 7.2 **Loans.** No loan shall be contracted on behalf of the Corporation and no evidence of indebtedness shall be issued in its name unless authorized by a resolution of the Board of Directors. Such authority may be general or confined to specific instances.
- 7.3 **Checks, Drafts, Etc.** All checks, drafts or other orders for the payment of money, notes or other evidence of indebtedness issued in the name of the Corporation, shall be signed by such officer or officers, agent or agents of the Corporation and in such manner as shall from time to time be determined by the Board of Directors.
- 7.4 **Deposits.** All funds of the Corporation not otherwise employed shall be deposited to the credit of the Corporation in such banks, trust companies, or other depositories as the Board of Directors may select.

VIII. Miscellaneous

- 8.1 **Books and Records.** The Corporation shall keep correct and complete books and records of accounts and shall keep minutes of the proceedings of all Board of Directors regular and special meetings and all committee meetings. Members of the Corporation shall have the right at any reasonable time, and upon written request stating the purpose thereof, to examine and make copies from the relevant books and records of accounts, minutes, and records of the Corporation.
- 8.1 **Indemnification.** The Corporation shall indemnify any director or officer or former director or officer of the Corporation against claims, liabilities, expenses and costs necessarily incurred by him or her in connection with the defense, compromise or settlement of any action, suit or proceedings, civil or criminal, in which such person is made a party by reason of being or having been such director or officer, except in relations to matters as to which such person shall be adjudged in such action, suit or proceeding to be liable for negligence or misconduct in the performance of duty to the Corporation, to the extent not otherwise compensated, indemnified or reimbursed by insurance.
- 8.2 **Fiscal Year.** The fiscal year of the Corporation shall begin on January 1 of each year.
- 8.3 **Investments.** The Corporation shall have the right to retain all or any part of any securities or property acquired by it in whatever manner, and to invest and reinvest any funds held by it, according to the policies of the Board of Directors, without being restricted to the class of investments which a director is or may hereafter be permitted by law to make or any similar restriction; provided, however, that no action shall be taken by or on behalf of the Corporation if such action is a prohibited transaction or would result in the denial of the tax exemption under Section 501(c)(3) of the Internal Revenue Code and its Regulations as they now exist, or as they may hereafter be amended.
- 8.4 **Annual Report.** The Board Chair and Executive Director shall cause to be prepared annual or other reports required by law and shall provide copies of such to the Board of Directors.
- 8.5 **Exempt Activities.** Notwithstanding any other provision of these bylaws, no director, officer, employee or representative of this Corporation shall take any action or carry on any activity by or on behalf of the Corporation not permitted to be taken or carried on by an organization exempt under Section 501(c)(3) of the Internal Revenue Code and its Regulations as they now exist or as they may hereafter be amended, or by an organization contributions to which are deductible under Section 170(c)(2) of such Code and Regulations as they now exist or as they may hereafter be amended.

IX. Amendments

- 9.1 **Amendments.**

- (a) Articles. The Articles of Incorporation may be repealed, amended, or restated only upon a two-thirds (2/3) affirmative vote of the Board of Directors and shall be effective only upon the filing of the Amended or Restated Articles with the Secretary of State.
- (b) The Bylaws may be repealed, amended or restated only upon a two-thirds (2/3) affirmative vote of the Board of Directors.
