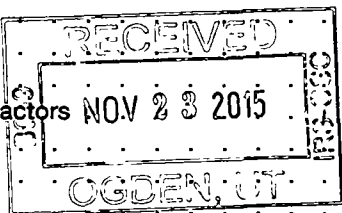



In 2014, Hands For Haiti continued supporting the Solidarity Center School in the village of Tremesea, Haiti. Funds were used as follows:

- 1) \$34,750. School operating fees (assistance to pay for teachers and staff).
- 2) \$77,489. Funds to complete construction and outfitting of new community center, also to be used for additional classrooms.
- 3) \$10,190. Funds to pay for 1 meal each day for the students of the Solidarity Center School.

- 1) \$4,500. Funds given to help construction of hospital in Plain-du-Norder by Haiti Mission Branche Nord / Dr. Eugene Maklin.

\$1,369 was spent on Paypal fees associated with collecting donations, as well as bank wire transfer fees for sending funds to Haiti for the three projects funded.
