SCSJ provides services directly for the benefit of the general public on a continuing basis through its regular Clean Slate Clinics held in community centers around the state, its free representation of clients, its dissemination of educational materials which include original research publications, and video presentations, and its office space, which is made available for community meetings upon request.

(c) **Broad public participation:** Members of the public having special expertise volunteer routinely to participate in the programs of the organization, most particularly law student interns and volunteer lawyers. Graduate students complete research projects for the organization, and civic and community leaders routinely request SCSJ staff to make presentations at public meetings. SCSJ maintains regular contact with the general public about its activities and programs through a website, facebook page and twitter account. The organization has a robust and growing list of supporters who have joined an email list to receive routine updates about our work.

(d) **General public fundraising activities:** In 2014 the organization used numerous tools to solicit public donations, including in-person fundraising events based in the community, on-line email solicitations, and personal appeals in small group meetings. The

annual fund development plan was devised by the Board's development committee, and carried out by organization staff throughout the year.
