TIGRA bundles financial and consumer services for immigrants and their families that promote social responsibility and reinvestment. In partnership with local credit unions and regional banks, secured credit card programs, accredited remittance companies, local immigrant-owned restaurants, and local food and grocery outlets that uphold labor and environmental standards, TIGRA provides "economic citizenship" education along with a suite of programs and services that exemplify the values of the organization. Targeted constituencies include Filipino newcomers, and those eligible for Deferred Action for Childhood Arrivals and their families.

TIGRA has launched two new campaigns in 2014 that addresses needs of our constituencies. First is the Divest in Detention / Invest in Communities project that works with stakeholders in universities with banking partnerships with financial institutions that invest in the detention industry. The goal is to explore new partnerships that are committed to community reinvestments. The other project involves recent refugee children from Central America that find themselves in Oakland schools while they go through their asylum proceedings. TIGRA has developed a Mentorship Program that matches local college students with these refugee children to provide support and nurture a welcoming environment.
