We organize a project called Portland Rising that puts thousands of workers and supporters in action together. We educated people around many campaigns, including the need for a higher minimum wage, postal workers struggling to keep the Postal Service strong and their jobs an important part of the community and the economy, and the efforts to support workers' struggles for decent standards for airport and longshore jobs.**

**Our immigrant rights committee continues to support struggles to make immigrants' difficult lives easier and at the same time allow them to better integrate into the society they do so much to support, via allowing them to obtain drivers licenses and get other services and recognition without which life and work are nearly impossible. We support efforts to enforce workers' rights laws for day laborers and farmworkers, two heavily immigrant areas of the workforce for whom workers' legal protections are de facto nearly nonexistent.**

**We work to educate the public and opinion leaders about the damaging effects of global trade and encourage them to oppose the often-hidden efforts to make working people's situation even more precarious that are presented as "free trade."
