To sponsor participation in college preparatory programs and to provide university scholarships for young Liberian adults who were academically disadvantaged by the 14-year civil war in Liberia.

PART III:

ORGANIZATION'S PRIMARY PROGRAMS:

SCHOLARSHIP PROGRAM:

Activities include ongoing review and refinement of university scholarship program goals and structure, equal opportunity policies, application, and terms. Scholarships are awarded to eligible Liberian students pursuing careers specifically identified as critically depleted during the civil war.

In 2014 Ebola seriously impacted Liberia and Raise Your Hand Foundation (RYHF). In an effort to curb spread of the virus, the Liberian government declared an official State of Emergency in July and all schools were closed effective immediately. All 113 RYHF sponsored students in partner universities, vocational training, and special educational programs were affected. Most had completed one semester of the academic year and some had started their second term at the time of closure.

Laws restricting public gatherings shut down businesses, international NGOs, public markets, and other societal structures that supported and employed people in the country. People began to suffer from hunger and lack of resources, and health care services were stretched beyond capacity to accommodate Ebola victims, so general health needs went unattended.

In August RYHF instituted "REACH: The Compassion Project". RYHF maintained regular contact with all scholarship recipients (and alumni), and through REACH provided food and medication stipends as needed. RYHF also partnered with the Sacramento community and the health administrators of Mother Patern College of Health Sciences (Monrovia, Liberia) to ship hundreds of thousands of dollars of urgently needed medical supplies and personal protective equipment for health care workers treating Ebola patients. Two shipments (September and October) were received and immediately disbursed to hospitals across Liberia.

RYHF also partnered with ASCEL BIO in Reno, Nevada to assist in building a communication network through which remote Liberian communities could be accessed for real-time case reporting and tracking of Ebola.

Due to increased generosity of donors during this critical time, RYHF was able to sustain the health and basic needs of all students and alumni. Several graduates of the RYHF nursing and social work programs worked throughout the crisis, treating patients and educating communities and health care workers; one RYHF nurse graduate died from contracting the virus through his work.

The Raise Your Hand Foundation Student Association (RYHF-SA) at Cuttington University (Suakoko, Liberia) remained active through Ebola. They organized and implemented Ebola safety training in their local community, funded through REACH. The vision for RYHF-SA has been to maximize individual potential, support success on college campuses, and to give back to the community through volunteerism. The initiative shown by the students and their actions on behalf of others amply reflected this vision in action.

Schools had not yet resumed at the end of 2014.

JOHN CHRISTIAN INTERNATIONAL SCHOOL (Formally Calvary Revival)

Over 500 students grades pre-K through 6 attend JCIS. RYHF continues to train and support the teaching and administrative staff. RYHF also sponsors the JCIS Vice Principal in an Educational Administration degree to meet government requirements for accreditation. During Ebola RYHF provided monthly distributions of rice for unemployed teaching staff and their families.

DANJA FISTULA CENTER AND LEPROSY HOSPITAL, NIGER REPUBLIC

RYHF has maintained an ongoing partnership with the Folsom Lake Vision Project (Folsom Lake Lions Club, Folsom CA). In 2014 RYHF sent a shipment of nearly 1,000 donated, refurbished and prescription labeled eyeglasses to the Leprosy Hospital in Danja, Niger, the fourth such shipment to date.
