4 Describe the organization's program service accomplishments for each of its three largest program services, as measured by expenses. Section 501(c)(3) and 501(c)(4) organizations are required to report the amount of grants and allocations to others, the total expenses, and revenue, if any, for each program service reported.

The Augusta Warrior Project has five established field offices in Georgia and three in South Carolina, out of which 13 trained advocates provide services. At this writing, there are 7196 total Warriors known to AWP. In 2014, AWP registered 2670 new Warriors, of which 1705 Warriors were connected to holistic support to improve their quality of life. The year-to-date accomplishments include permanently housing 61 formerly homeless Veterans, assisting 156 warriors with utility bills through Georgia's Project Share, enrolling and sustaining 493 Warriors in post-secondary education and training, assisting and coaching 261 unemployed Warriors into jobs, and assisting and referring 726 Warriors for benefits. Program highlights of 2014 include - Fort Gordon Transition Success Center (TSC) Grand Opening. With the establishment of the TSC, Service Members, Veterans and Family Members have a location on the Installation that affords them the opportunity to meet one-on-one with AWP coordinators in the areas of Benefits, Employment and Education - Bob Woodruff Grant - AWP received a grant from the Bob Woodruff Foundation to help facilitate successful transition and reintegration for service members into the civilian workforce - George W. Bush Institute Visit - Augusta Warrior Project, Inc., was recognized by the George W. Bush Institute as being impactful to veterans and/or military families. As a result, AWP was invited by the Bush Institute to serve as one of the 25 case studies for the Model of Excellence in veteran-serving nonprofits.

In August 2013, Augusta Warrior Project was provided an opportunity through generous grant funding from Wounded Warrior Project to replicate the Augusta Warrior Project model of holistically supporting warriors through interpersonal relationships. In 2013, Augusta Warrior Project - National operations developed community development tools, metrics, and measures to prepare to engage with six communities in 2014. In 2014, the national operations started three of the projects. As this grew, it was determined that the best way to proceed was to stand up the national operations as a separate company, the America's Warrior Partnership, and that transition was completed in August 2014 with the separation of select staff and the generous grant funding awarded by the Wounded Warrior Project.
