AFYA collected, sorted and distributed surplus medical equipment and supplies worth over \$4 3 million for use by health and relief organizations in Africa and the Caribbean, as well as areas of emergency need (eg earthquake and hurricane relief efforts worldwide) These supplies are collected from our network of hospital partners in the greater New York area All collection and sorting is accomplished through volunteers in our Yonkers-based warehouse Providing medical and humanitarian supplies during times of disaster is one aspect of AFYA's work In December of 2013, AFYA received a large non-cash donation of relief supplies These items were shipped in early 2014 to the Phillippines in response to Typhoon Haiyan As such, these items were booked as revenue in 2013 and expensed in 2014 The value of this donation was approximately \$1,300,000
