The Mohamed bin Zayed Species Conservation Fund is a permanent endowment fund established in the UAE that provides funding to support conservation efforts for all living things. Jim Sanderson, founder and director of The Small Wild Cat Conservation Foundation, sits on the review panel and reviews wild cat proposals for the Mohamed bin Zayed Species Conservation Fund. The Small Wild Cat Conservation Foundation uses its funds to leverage more wild cat projects to be funded. Also The Small Wild Cat Conservation Foundation uses its funds to develop new projects where none exist. Together with the Mohamed bin Zayed Species Conservation Fund approximately \$82,000 in wild cat conservation projects were funded.

In 2014, The Small Wild Cat Conservation Foundation provided \$5400.00 in camera traps to a wild cat project in Uganda.

4c (Code:) (Expenses \$ 3246.70 including grants of \$) (Revenue \$)

The Small Wild Cat Conservation Foundation presented several camera trap data processing workshops in Thailand, Malaysia, and Sarawak. Presentations were made describing the Mohamed bin Zayed Species conservation Fund and encouraging new proposals to support wild cat conservation projects.
