The Small Wild Cat Conservaion Foundation uses its funds to leverage more wild cat projects to be funded. Also The Small Wild Cat Conservaion Foundation uses its funds to develope new projects where none exist. Together with the Mohamed bin Zayed Species Conservaion Fund approximatey \$82,000 in wild cat conservaion projects were funded.
