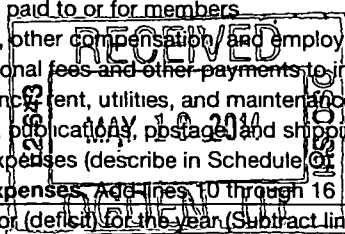

and opportunity to help them end the injustices of poverty and to bring about sustainable solutions in their individual lives and

villages.

Part III #28 Health Program: 1500 women received cervical cancer screening. All with high grade dysplasia or micro-invasive disease were

treated with cryotherapy or LEEP conization. Meetings were held with the Ministry of Health in Guatemala to find ways to decrease the rate of

cervical cancer in Guatemala. SewHope's efforts to reduce cancer in Guatemala were featured on the front page of the "Prensa Libre", the

leading newspaper in Guatemala. 200 women received prenatal care according to the WHO's "Safe Motherhood Initiative". The first free

standing Birthing Center in the Peten is nearing completion with funds raised by SewHope benefactors. Medical Mission teams completed

15 weeks of care for the poorest of Guatemala. 18 families received efficient, safe cooking stoves. 75 water filters were installed in homes.

PART III #29 Education Program: 83 children were enrolled in our after school education program. The program offers computer and internet

based teaching in reading and mathematics. In addition, we teach concepts aimed to expand the childrens' world-views. Testing has been

completed to form a baseline for knowledge. Some of our programs have been based on the SOLES program initiated by Dr. Sugata Mitra

from MIT. Sr. Pamela Buganski spent the year in Guatemala working with teachers in a local school in Purushila to enhance their teaching

materials and skills. They subsequently won a national award for outstanding teaching.

PART III #30 Nutrition Program: Nutritionally complete meals were provided to all students at 15 local village schools in the Peten.

90 families participated in family grown vegetable gardens. SewHope started a "model" home where all of the examples of good nutrition are

taught to local villagers: vegetable gardens, coops for raising chickens, and a fish farm.

PART III # 31 Two acres of land were purchased in the Santa Ana region with the purpose of building a facility that will house a medical clinic

and an area for the after school education program. Projects aimed to help the women of the Peten establish means to support themselves

and their families were continued: shampoo making, sewing, hair cutting
