Grace Medical Home has experienced tremendous growth in the past five years We serve as the only comprehensive medical home exclusively for low-income, uninsured Orange County, FL residents We offer primary care adult and pediatric medical services through an ongoing relationship with a personal physician and excellent care The Organization’s services include primary and preventative care, in-house labs, digital x-ray, vaccinations, diabetes education, treatment of acute and chronic illnesses, and on-site medical specialties including cardiology, mental health counseling, endocrinology, ophthalmology, vascular, and more The services also include access to donated medications valued at more than \$1 8 million This includes more than \$700,000 of medications donated directly to the Organization and the balance provided directly to the patients through a program administered by the Organization The Organization has enrolled approximately 2,400 patients, had roughly 10,000 patient encounters in 2014, and offers 20 medical specialties on-site Our medical outcomes of our chronically-ill patients demonstrate that we are improving people’s health so they can remain on the path of self-sustainability Last year we were able to add a second location so we could expand mental health and spiritual care services We also strengthened our partnership with the UCF College of Medicine through the KNIGHTS Clinic where medical school students and their attending physicians serve the Organization’s patients twice a month at this student-run clinic And, we were 1 of 7 free clinics in the country selected to participate in a national study offering the CDC’s Diabetes Prevention Program to help patients at risk for developing diabetes adopt lifestyle choices to prevent the illness We were also recognized and certified by the National Committee on Quality Assurance as a Patient-Centered Medical Home
