The Organization maintains a clothing store called the Clothes Cabin which provides a location for individuals in need to "shop" for necessary items up to four times per year. In 2014, there were 10,717 visits to the store by 5,849 different individuals or 1,825 families. While the Organization occasionally purchases needed items to be provided to our clients, during 2014 donated goods with a fair market value of \$ 426,106 were received for distribution.
