The Advance Illinois search committee utilized Isaacson, Miller to recruit the executive director position. On June 5, 2008 Tim Knowles, interim chair (on the behalf of the independent board of directors) sent an offer letter to Robin Steans who accepted the ED position. This contract, signed by Tim Knowles, served as the contemporaneous documentation with respect to the deliberation and decision regarding the compensation arrangement. The organization engaged a consulting company to provide an assessment of market practices to determine the appropriate compensation for the Executive Director. Until 2013, no adjustments were made to the ED's original base compensation in the employment contract. In February 2011 (for FY 2010), December 2011 (for FY 2011), December 2012 (for FY 2012), December 2013 (for FY 2013), and December 2014 (for FY 2014) the Advance Illinois board approved 20% bonuses for Robin based on her base compensation (as outlined in her offer letter).</p>
