TO ACCOMPLISH THIS MISSION, FORWARD MONTANA FOUNDATION FOCUSES ON NONPARTISAN VOTER REGISTRATION, LEADERSHIP DEVELOPMENT AND GET-OUT-THE-VOTE (GOTV) EFFORTS. VOTER REGISTRATION.
