

Community ReUse Center: Open daily, donation of goods and materials are accepted, processed and resold back into the community. Pick-up and delivery services and computer repair services are also offered. Annual sales exceeded 3,750 furniture items, over 7,000 computer and electronic items, more than 40,000 household items including appliances and 37,960 unit items of building materials were sold back into the community and diverted from landfills. The Center received over 34,000 visits and more than 175 tons of material was received in donations. Sales of donated products provided over 70% of the revenues of the Center.

Deconstruction Program: 14 Projects were performed ranging from kitchen to building removals. Deconstruction is performed using hand tools in order to salvage a maximum amount of material. Materials in good condition collected from deconstruction projects are resold to the community. In 2014 resale of material totaled more than \$15,000. Over 12,000 units of recovered lumber were resold.

Community Education and Outreach: The Reset job training program, with curricular tracks in construction, technology, and retail customer service served 29 participants. Participants in the Ithaca Fixers Collective repaired 143 household items and returned them to active use. The community reuse center template, providing an online tool to assist communities in creating their own independent reuse operations based on Finger Lakes ReUse model, had 44 registered users. Apprentice program provided 2,440 hours of employment for participants learning technology skills.
