We are a 501 (c)(3) Non-Profit Organization That has formed to do trail Maintenance and Support of the Cohutta Wilderness and Conasauga Ranger District, US Forest Service. All Volunteers pay for their own transportation to get to the site to do volunteer work. Although gas prices have gone down recently, it has become increasingly hard to get volunteers to do this type of work. We do not submit for grants although there may be grant opportunities available. We receive donations from some of our own volunteers. We have expenses such as maintaining a web site + pay yearly dues to the Georgia Soc of State. Our volunteers do this work to keep trails safe for hikers, horseback riders and maintain hikers. Our group believes in volunteering to conserve forest resources and to give back to society.
