WE HAVE DEDICATED VOLUNTEERS WHO FAITHFULLY COME TO FILL AND DISTRIBUTE FOOD ORDERS. THE FOOD PANTRY IS STOCKED THROUGH THE SUPPORT OF OUR CHURCHES AND LOCAL BUSINESSES. BULK SUPPLIES ARE PURCHASED FROM THE MOUNTAINEER BANK. 2,347 FAMILIES WERE ASSISTED IN 2014.
