A GRANT WAS MADE TO THE UNIVERSITY TO DEDICATE A CONFERENCE ROOM WHERE MEETINGS FOR COCHLEAR IMPLANTED CHILDREN AND THEIR FAMILIES CAN MEET WITH STAFF, AS WELL AS PROVIDING AN AREA FOR THE COCHLEAR IMPLANT TEAM TO MEET AND EXCHANGE IDEAS. THE RESOURCE CENTER WAS OPENED IN 2010 AND IS PROVIDING SERVICES TO FAMILIES OF HEARING IMPAIRED CHILDREN.
