HEALTH CLINIC - NENO DISTRICT, MALAWI

THIS HEALTH CENTER INCLUDES A LAB, DISPENSARY, TREATMENT AND CONSULTATION FACILITIES AND OFFICE SPACE. IT ALSO REQUIRES SUPPORT FACILITIES FOR THE REMOTE NATURE OF THIS REGION. BOREHOLES AND PUMPS TO PROVIDE RUNNING WATER AND SOLAR SYSTEMS AS THE AREA IS OFF THE NATIONAL POWER GRID.

THE 30/30 PROJECT ADDRESSES THE NEED FOR FREE, BASIC PRIMARY CARE AND LOWER THE BARRIER TO ACCESS. THERE IS NO OTHER PUBLIC FACILITY IN THIS IMPOVERISHED REGION.

KEY PROGRAMS INCLUDE TREATMENT AND PREVENTION FOR COMPLEX DISEASES SUCH AS HIV, TUBERCULOSIS, AND DRUG-RESISTANT TUBERCULOSIS, AS WELL AS INITIATIVES TO TREAT AND PREVENT MALARIA, REDUCE MATERNAL MORTALITY RATES THROUGH FAMILY PLANNING AND ANTENATAL CARE, AND TREAT CHILDHOOD MALNUTRITION.

HEALTH CLINIC - MBITA, KENYA

THIS CLINIC REPLACES THE EXISTING FACILITY AS THE GROWING NEED IN THE AREA HAS SURPASSED THE CURRENT CAPACITY. WITH AN AVERAGE OF 45 PATIENTS PER DAY AND A HIGH OF 68 PATIENTS PER DAY, ADDITIONAL SPACE WAS NEEDED TO MEET THE INCREASING PATIENT FLOW. THE PROJECT ALSO FUNDED A MUCH NEEDED MORTUARY TO SERVE THE REGION, VOLUNTEER HOUSING, ECO-FRIENDLY TOILETS, RAIN WATER COLLECTION SYSTEM, SEWAGE SYSTEM, GUARD HOUSE, FENCING AND GATE FOR PROPERTY, AND SOLAR EQUIPMENT FOR CRITICAL CLINIC SERVICES.

COMMUNITY BUILDING / SCHOOL - PHALOMBE DISTRICT, MALAWI

THIS STRUCTURE SERVES ALL AGES AND ALLOWS FOR THE EXPANSION OF PROGRAMS INCLUDING TUTORING, HEALTH EDUCATION AND HIV/AIDS AWARENESS, AND COMPUTER PROGRAMS.

COMMUNITY BASED ORGANIZATIONS UTILIZE THE BUILDING'S CLASSROOMS WHILE NOT IN USE FOR OTHER PROGRAMS. THESE COMMUNITY BASED ORGANIZATIONS FOCUS ON ISSUES SUCH AS EDUCATION, EMPOWERMENT OF THE GIRL CHILD, HEALTH EDUCATION, HIV/AIDS AWARENESS, CLEAN WATER, HEALTHCARE, AND THE ENVIRONMENT.

ANNUALLY THE BUILDING WILL SERVE 750 STUDENTS, 250 ADULTS IN THE LITERACY PROGRAM, 250 COMMUNITY MEMEBERS THROUGH THE SUSTAINABLE LIVELIHOODS PROGRAM, OVER 1,000 COMMUNITY MEMBERS INTERACTING WITH COMMUNITY BASED ORGANIZATIONS, AND OVER 2,000 COMMUNITY MEMBERS THROUGH VARIOUS OFFICE ACTIVITIES.
