ALL 11 UF COMMUNITIES HAVE A SCHOOL FARM, TENDED BY STUDENTS THAT PROVIDE NUTRITIOUS FOOD SUCH AS KALE FOR STUDENT LUNCHES THAT ARE COOKED IN THE COMMUNITY KITCHEN - MOST IMPORTANTLY, STUDENTS HAVE TAKEN OWNERSHIP OF THEIR HEALTH AND ESTABLISHED HEALTH AND ENVIRONMENTAL CLUBS EIGHTY-NINE PERCENT OF HOUSEHOLDS ARE NOW PRACTICING HEALTHY HABITS AT HOME SUCH AS HAND WASHING AND DISH DRYING INCOME - IN 2014, 600 HOUSEHOLDS PARTICIPATED IN A VILLAGE SAVINGS AND LOANS PROGRAM (VSLA) THAT ALLOWS MEMBERS TO POOL RESOURCES AND TAKE OUT LOANS FOR SMALL BUSINESSES - THE ALTERNATIVE INCOME AND LIVELIHOOD PROGRAMS ARE WELL ESTABLISHED THE GOAL OF THIS PILLAR, AS WITH THE OTHERS, IS TO MAKE THE COMMUNITY ECONOMICALLY SELF-SUFFICIENT TO THAT END, THE UF HAS SPONSORED FINANCIAL LITERACY TRAINING THAT'S BEEN DELIVERED TO OVER 58 MEN AND WOMEN'S GROUPS IN ALL 11 COMMUNITIES -
