



The program, located in Haiti and partnered with Christianville Foundation, Inc. provides Haitians the necessary training, financing, and oversight to begin his/her own small poultry business in order to learn a life of dignity and self-reliance.

The organization donated \$254,825 towards the funding of the Highest & Best (H&B) programs. The program, located in Haiti and partnered with Christianville Foundation, Inc. provides Haitians multiple solutions to extreme poverty in Haiti by providing Haitian farmers new technologies and techniques to improve his/her farm production and also will provide vital skills training and education to Haitians in order to help develop marketable skills and stimulate job creation.

The organization donated \$73,205 towards the funding of the 6.25 feeding program. The program, located in Haiti and partnered with Christianville Foundation, Inc. provides animal protein to children who otherwise would not have access to it. Poultry is purchased from SHPE farmers and distributed to malnourished children in several regions of Haiti.
