COMING HOME IDENTIFIED THESE STAKEHOLDERS IN THIS INITIATIVE: FINANCIERS, MUNICIPALITIES, AFFORDABLE HOUSING DEVELOPERS AND SERVICE PROVIDERS. CHM ACTS AS A CATALYST FOR THE CREATION OF AFFORDABLE HOUSING FOR THOSE WHO ARE HOMELESS. PRIOR TO THE H4H PROGRAM, CONSTRUCTION OF AFFORDABLE HOUSING WAS OFTEN FOLLOWED THE MONEY, WHETHER OR NOT THERE WAS A NEED FOR THE CONSTRUCTION OF THE PARTICULAR HOUSING BEING BUILT. FOR EXAMPLE, IF THE GOVERNMENT OFFERED FINANCIAL INCENTIVES FOR HOUSING FOR VETERANS OR FOR THOSE WITH DEVELOPMENTAL DISABILITIES, THEN THAT IS WHAT WOULD BE BUILT. WHETHER OR NOT THERE WAS AN OBJECTIVE NEED FOR SUCH HOUSING AMONG MIDDLESEX COUNTY'S HOMELESS POPULATION, THE GOAL OF H4H IS TO CREATE AFFORDABLE UNITS TO FOLLOW THE NEED, NOT THE MONEY. IN 2014, COMING HOME WORKED TO COLLECT AND ANALYZE RELEVANT DATA ON THE CAUSES AND INCIDENCE OF HOMELESSNESS, IDENTIFIED PROPERTIES AND POTENTIAL SOURCES OF FUNDING FOR THE CREATION OF HOUSING NEEDED BY THOSE WHO ARE HOMELESS, PRESENTED RESULTANT OPPORTUNITIES TO THE TEAM OF AFFORDABLE HOUSING DEVELOPERS IT HAS CULTIVATED AND ASSISTED IN THE DEVELOPMENT OF A PROJECT-SPECIFIC DEVELOPMENT TEAM FOR THE CREATION OF SUPPORTIVE HOUSING FOR THE HOMELESS. SPECIFICALLY, CHM HAS BEGUN A PROJECT WITH THE NEW BRUNSWICK HOUSING AUTHORITY FOR THE DEVELOPMENT OF LAND TO CREATE 12 UNITS OF HOUSING, ALL DEDICATED TO THE FORMERLY HOMELESS. ALSO IN 2014, CHM AND THE COUNTY FINALIZED THE DEAL, CONTEMPLATED IN THE COUNTY'S PLAN TO END HOMELESSNESS, WITH A PARTNER DEVELOPER, THE ALBERT GROUP, TO CREATE 120 UNITS OF AFFORDABLE HOUSING ON THE FORMER KILMER ARMY BASE, OF WHICH 30 ARE DEDICATED TO PERMANENT HOUSING FOR THE FORMERLY HOMELESS. BY VIRTUE OF THE CONTINUED CREATION OF PARTNERSHIPS AND COALITIONS VIA THE H4H PROGRAM, CHM IS OPTIMISTIC ABOUT EVENTUALLY PROVIDING HOUSING FOR ALL THOSE EXPERIENCING HOMELESSNESS IN MIDDLESEX COUNTY.
