In 2014, Lucky Family Mission purchased another home for Purchased, which is a ministry for prostitutes and strippers We also are in the process of opening a home for sexually abused children We funded a mission trip for saving souls in Haiti and Nepal India We purchased Bibles for vanous organizations We helped with Eagle Creek Recovery Center, a Christian based alcohol and drug rehabilitation center We built a Cowboy for Christ Cross and monument representing Christian cowboys everywhere We helped several less fortunate families during Christmas where the children had no presents or food Lucky Family Mission also donated heavily to Global Ventures, a Christian based missionary group that travels to several countries a year preaching the gospel of Jesus Christ We helped fund Costa Rica, Haiti, Nepal, Thailand, and Romania The Mission gave \$80,000 to John Smithwick Ministries to help with the cost of overhead at the school's headquarters in OK Funds were also donated to local churches for local ministries as well as to ministries for religious travel and study We purchased a home to hold Bible studies for the high school students The Bible studies were conducted weekly or bi-weekly in the home Speakers were brought in to speak at the Bible studies The mission also purchased uniforms for hundreds of South Bossier schools through the ministry called Faith Moving Mountains and fed hundreds of young children through Bellaire Baptist Church Again, we believe that God has tremendously blessed our mission and we are able to give to others through this mission
