	The Iowa Cancer Consortium (ICC) convened groups around the four Cancer Plan goals prevention, screening, treatment and quality of life The ICC distributed more than 20 community-based implementation project peer-reviewed grants throughout the State At a skills-training workshop led by national palliative care expert, 46 healthcare participants learned, interacted, and practiced communication skills surrounding difficult conversations with patients and families In partnership, the ICC developed and field tested a web-based quality-of-life and stress-management program that ovarian cancer survivors can access at home The online intervention covers information that might not otherwise be easily accessible to rural Iowans facing a less common cancer The ICC implemented an EPA grant which resulted in 53 homes completing radon testing, 16 homes receiving radon mitigation, and more than 1,500 bilingual radon brochures distributed across Polk County Members and volunteers contributed over 2,000 in-kind hours for ICC activities The activities of the ICC and its partners reached individuals in each of Iowa's 99 counties

	The ICC presented a two day Cancer Summit, the only meeting addressing comprehensive cancer control topics such as prevention, screening, treatment and quality of life for cancer survivors in Iowa. Over 130 Iowans attended representing cancer centers, public health agencies, cancer related nonprofit organizations, cancer survivors and advocates. Participants heard a keynote address from Dr. Patricia Ganz, MD who discussed Delivering High-Quality Cancer Care: Charting a New Course for a System in Crisis. Over 30 presenters offered insight and guidance on implementation efforts to address cancer prevention, screening, access to treatment and quality of life issues. This forum to network and exchange best practices in cancer control continues to grow each year.
