Research and clinical Global's primary focus is to support the Linda Crnic Institute for Down syndrome, the first academic home in the United States committed to research and medical care for people with Down syndrome Grants to the Linda Crnic Institute totaled \$500,000 in 2014 Another \$500,000 was provided to the national Alzheimer's Disease Association for a joint Down Syndrome-Alzheimer's Disease Research Investigator Program The research conducted by the Institute and through the investigator program focuses on sleep apnea, physical delays, Alzheimer's disease, congenital heart disease, and autism-diseases and conditions that a large number of people with Down syndrome have

Health and education In November 2012, Global and the National Down Syndrome Congress (NDSC) co-published and began distributing the Prenatal Testing Pamphlet (PTP) The pamphlet is distributed directly from Global and the NDSC and through the largest prenatal testing company, Sequenom The PTP is free of charge to people or organizations providing resources to pregnant women or their medical providers Medical providers or professionals include, but are not limited to, doctors, nurses, and genetic counselors Organizations include hospitals, universities, OBGYN offices, and Down syndrome organizations (Continued on Schedule O)In March 2014, Global commissioned a multi-phase, multi-targeted national research project in order to garner feedback on and ideas for enhancing the PTP to reflect what information is important to pregnant women and medical professionals The findings from that research have been incorporated into a new version of the PTP, which will be distributed in mid-to late 2015 Global also supports the Crnic Institute's Sie Center for Down Syndrome to provide the best multidisciplinary care for children with Down syndrome The Sie Center is working to update medical guidelines for children with Down syndrome, and will help to ensure that families, doctors and other healthcare providers have access to updated information The Sie Center received a grant from Global in the amount of \$170,918 in 2014 In addition, Global issued educational grants in the total amount of \$92,500 to local and national Down syndrome organizations in 2014

Outreach The goal of Global's outreach programs is to provide the highest quality health oriented activities and education to people with Down syndrome and their families Global staff learn from programs launched by other organizations, and in turn, encourage and help others to launch similar programs Additionally, these programs help ensure people with Down syndrome have the opportunity to have fun, gain confidence, excel and reach their potential which effects many areas of their lives In support of these goals, Global hosts Dare to Play camps Football, Cheer, Soccer, several dance classes and an educational series all of which promote mental and physical wellness (Continued on Schedule O) Moreover, Global conducts roundtables, workshops, and briefings on Alzheimer's disease-Down syndrome research and advocacy All of the aforementioned programs are designed to help people with Down syndrome dream big so they can not only meet, but exceed their expectations
