 The organization's primary exempt purpose is to provide meaningful outdoor education experiences for youth. This is done through curriculum-based multi-day wilderness river programs that incorporate healthy risk-taking, leadership building, academic lessons, team-building exercises, and conservation education.

28 In 2014, GOALS worked with children from all over the country to design and implement customized outdoor experiential learning opportunities for kids between 4th and 12th grade. The number of children we serve continues to increase, as does the scope of our programming. In 2014, we fortified our "Class II and Class III programs" for middle- and high-school students with a new growth guide that leads kids through a powerful search-navigate-reflect-believe growth process. GOALS programs in 2014 explored Desolation, Gray, Lodore, Labyrinth, and Stillwater Canyons of the Green River as well as Ruby, Horsethief and Cataract Canyons of the Colorado River and the Wild and Scenic Section of the Rogue River. We are able to offer such wide programming options through partnerships with Sheri Griffith Expeditions in Moab, UT and ARTA in Groveland, CA. In addition to expanding our curriculum and increasing our program options, GOALS continues to solidify the educational experiences we provide by offering new leadership opportunities for students who have taken part in GOALS programs previously and are now interested in providing mentoring for younger students.
