Special Project Writing - In addition to its other program emphases, CLI supports individual ad-hoc writing and research projects on various topics in bioethics and sanctity of human life issues These projects include policy papers, fact sheets, and commentaries for publication on CLI's web site or in the general media (print or electronic), blogs, and other formats Writers are drawn from the CLI's list of expert advisors or others with special skills but no official role with CLI In 2014 special project writing included a report on the impact of the Supreme Court ruling on major abortion regulations from Texas, an update on abortion insurance coverage limits in the states, an update on scientific evidence about the beginning of individual human life, and the evidence that all forms of emergency contraception can act in an abortifacient manner
