HIP's mission is to transform the policies and places people need to live healthy lives by increasing the consideration of health and equity in decision-making.

Research: HIP conducts policy-focused, innovative, and strategic research that evaluates health impacts and inequities to support targeted campaigns and movements for social change. In 2014, HIP completed eleven such research projects - including Health Impact Assessments - across the country with more than twenty community, policy, academic, and government partners. The projects were of relevance nationally and locally, and focused on topics such as sentencing reform, school funding and school discipline, economic security, and land use planning. An additional four research projects also began in 2014.

4b (Code) (Expenses \$ 342,566. including grants of \$ 2,500.) (Revenue \$ 123,547.)

Capacity building: HIP provides training and technical assistance to build the capacity of impacted communities and their advocates, public agencies, and elected officials to take action on the social determinants of health and equity. In 2014, HIP conducted 12 trainings and provided technical assistance to over 30 community organizations and government agencies across the country to build their capacity to conduct Health Impact Assessments and related projects. HIP also built the capacity of community organizations to integrate a public health approach in their organizing campaigns. Finally, HIP launched the Public Health and Equity Cohort, a leadership development initiative to tackle the structural and institutional challenges facing local health department practitioners who want to advance health equity work.

Awareness building: Through various communications strategies, HIP works to raise awareness of: the relationships between health and social, economic, and environmental decisions; the ways in which public health can collaborate with other social justice movements; Health Impact Assessment and Health in All Policies - and the values that underpin these fields - as ways to improve health and reduce inequities; and successes and impacts that using public health research and framing can have in community organizing campaigns. In 2014, these strategies included presenting at eight conferences/networks, publishing 35 blog posts; earning over 15 media hits profiling our work; publishing two journal articles; releasing two technical tools; creating two videos profiling our projects and partners; and sending out six organizational newsletters.
