Innovators Robotics organization's goals are to foster the growth of tomorrow's inventors and engineers by providing them with vital tools and resources for success, by increasing youth involvement in STEM and sustaining interest through the years, by building community pride and support for STEM education and programs by demonstrating the positive impact STEM programs have on students' lives.

Additionally, we aim to maintain a high level of accomplishment in FIRST robotics competitions while instilling valuable STEM skills in students and activating mentor relationships and teamwork skills based on common interests.

Winning the Engineering Inspiration award at Central Illinois in 2014 was the highlight of our competition season, but providing a significant service to our community was the highlight of our year. Our team was asked to design a curriculum and run a summer robotics camp for three different age groups at the Dayton Kroc Center, an inner city community center. This opportunity is directly in line with our mission statement: to increase the number of STEM opportunities in the educational system and inspire students to explore and pursue STEM careers.

We continually provide our community with demonstrations, volunteer services, teaching and training. A few examples of this year's outreach events include a booth at the Wright Patterson Air Force Base Museum. This event allowed visitors to see robots in action.

Our team has completed more than 125 outreach projects over the last five years helping to grow the STEM community.

Each summer we have found innovative ways to spread the FIRST message—the inner city summer camp, five weeks of visiting Boy Scout camps and helping scouts earn their robotics badges, participating in a nonprofit fair, and building a robot to throw out the first pitch minor league baseball game.

Our organization continues to create the engineers of tomorrow; we have graduated 23 seniors since our inception and 21 are in four-year college programs with 19 of them studying engineering. Our graduates have received more than 1.2 million dollars in college scholarships. Our graduates frequently come back to our build site and come to our competitions and talk to us about becoming engineers, about how each student can take advantage of the experience they are gaining, and how STEM programs has influenced their lives.

It is about building our knowledge, creating opportunities, teaching and training others, reaching out and partnering with our community, and Gracious Professionalism.
