All residents were served by case managers who assisted the residents with goal setting, problem solving and connecting with area resources. Also, during their stay at the Shelter, residents were counseled in the area of personal care, family living, financial responsibility, job interviewing, and employment. Thirty-one (31) percent of Shelter residents left the program having housing and employment.
