Shelter equipment and fixtures--

FOTAS funded the purchase of a 2013 model van to transport shelter animals to adoption events and transfer points, signs to direct visitors and staff, chain link covers for dog kennels to prevent escapes, cat condos to display adoptable cats in the lobby, sod for the lawn, a stack washer and dryer for the surgical room, and many other smaller items for the new shelter which was completed in March 2014. These purchases supplemented county taxpayer funds to make the shelter more habitable, safe and inviting for animals, staff and visitors.

Spay and neuter financial assistance program--

To reduce the number of unwanted animals euthanized at the county animal shelter, FOTAS funded spay and neuter surgeries for 556 dogs and cats in Aiken county in 2014. Spay and neuter assistance is a long-term program to eliminate pet overpopulation which causes over-crowding and high euthanasia rates in the county animal shelter.

Animal Transfers to no-kill shelters--

Due to over-crowding at the county animal shelter, FOTAS worked aggressively to transport as many adoptable animals as possible to no-kill shelters. The transfer program includes an extensive network of volunteers who foster dogs until they are old enough and healthy enough for transport. In 2014, FOTAS facilitated the transport of 1,107 cats and dogs to no-kill shelters for adoption.
