The vision of 1040i is to transform the lives of people in need by fighting pain and suffering in the most isolated places on our globe.
The primary focus will be centered on health and education needs between 10 degrees and 40 degrees north of the equator spanning
across North Africa and the Middle East.

Projects and Trips: This is 1040i's largest program. In 2014, 1040i conducted 2 trips to Cote d'Ivoire that provided medical services to the local people, with 5 surgeons using a mobile surgery unit. 117 surgeries were performed, including orthopedic surgeries, cleft palate repairs, removal of tumors, OBGYN procedures, and cataract surgeries. Almost 600 pairs of eyeglasses were distributed in conjunction with eye testing. Additionally, a construction team roofed, painted and supplied a school, and built school desks for it. There were 93 volunteers on these two trips.

Rejoice Bilingual Academy: 1040i completed building this bilingual academy in Tanda, Cote d'Ivoire in 2014 to change poverty through education. This academy will instruct in both French and English from 1st grade through 12th grade, and upon graduation students will receive a dual American and Cote d'Ivoire diploma. 1040i will own the academy facilities, and the staffing and operations of the academy will be managed by a private school in Oklahoma. The academy was completed and began operations in 2014. The academy will instruct in normal primary and secondary educational areas, as well as in technology. The expense amount of \$263747 reflected above does not appear in the 2014 income statement of 1040i, but rather has been capitalized as a fixed asset and is reflected on the December 31, 2014 balance sheet.
