We were unaware of this situation because we have no record of receiving a letter from the IRS informing us of this change of status. We had submitted the annual forms we thought were the required ones following Legal Zoom's advice.

We are using QuickBooks for our record keeping and are working with a CPA to make sure our finances are in order from here forward.

Due to the sudden resignation of the former President and Secretary, the unexpected death of a key board member, and the loss of important financial records we do not have an accurate accounting of budget expenses. We do, however have the totals of income and expenses over the past four years. We hope this will be sufficient.

We are very sorry for this mistake on our part. We only discovered we had fallen out of status when we went to file with another organization that let us know we were out of status. We hope these forms will be adequate to reinstate us.
