

2) The Traditions Fund is a permanent, irrevocable endowment fund which provides a steady source of revenue to MLR for bridge capital for property acquisition, for option purchases for all or a portion of a threatened property to be resold to a conservation buyer, or for conservation easement purchases. Interest, dividend income, and other income (excluding capital gains) may be used to cover expenses incurred by MLR for the following purposes: fee purchase of property to be resold by MLR; with other monies for the purchase of property to be resold; to purchase conservation easements; to acquire options to purchase property; or, as a loan to other entities exclusively for the purchase of property to be conserved -- the loan secured by an equity interest in the property, and to insure the long-term stewardship and monitoring of easements acquired with funds from the Traditions Fund. The corpus of the Fund may not be used. Any use of the Traditions Fund is authorized by a vote of the Board of Directors.

The Montana Land Reliance Foundation granted \$432,973 to The Montana Land Reliance to cover costs related to: 1) stewardship/monitoring of the conservation easements MLR held and monitored in 2014 (\$270,401); and 2) outreach activities to educate landowners, public officials, and the general public (publications, travel, printing -- \$162,572).

PART IV, line 1c:

The Montana Land Reliance Foundation received grants from The Montana Land Reliance totaling \$226,771 during the tax period. These monies are invested to generate income for MLR's operations, education and outreach activities, and stewardship and monitoring activities. There was \$125,606 invested in the Foundation's Land Protection Fund and \$101,165 invested into the Foundation's Education and Outreach Fund.
