THE BLUEFIELDS BASIC SCHOOL (NURSERY SCHOOL) PROVIDES EARLY CHILDHOOD EDUCATION TO CHILDREN AGED THREE TO SIX, AND CURRENTLY SERVES APPROXIMATELY 65 CHILDREN. WE SUPPLEMENT TEACHERS’ SALARIES. AS TREASURER OF THE SCHOOL, WE OVERSEE ALL ASPECTS OF HOW MONEY IS SPENT. THIS INCLUDES BUYING FRESH FRUITS AND VEGETABLES FOR SCHOOL LUNCHESES, PURCHASING MEAT AND PAYING A COOK TO PROVIDE THE CHILDREN A HOT LUNCH. WE TAKE A PARTICULAR INTEREST IN THE CHILDRENS’ DIET AS OBESITY IS A GROWING PROBLEM IN JAMAICA AS A RESULT OF AN ABUNDANCE OF PACKAGED FOOD. BECAUSE THE SCHOOL CANNOT AFFORD ELECTRICITY, WE CONTRIBUTED TO THE COST OF HAVING SOLAR LIGHTING AND SOLAR BATTERY ENERGY INSTALLED IN THE SCHOOL. WE ALSO PAY FOR SMALL-BUT-IMPORTANT ITEMS, SUCH AS HAVING THE SCHOOL FIRE EXTINGUISHERS SERVICED REGULARLY, AND HAVING SURROUNDING FENCING CONSTRUCTED AND REPAIRED. THE BELMONT ACADEMY (HIGH SCHOOL) BEPA PURCHASED AND DELIVERED FRESH FRUITS AND VEGETABLES FOR THE ACADEMY’S CAFETERIA SO THAT IT CAN PROVIDE FRESH AND HOT FOOD FOR THOSE STUDENTS THAT ARE UNABLE TO AFFORD TO PURCHASE LUNCH.

THE BELMONT ACADEMY IS A HIGH SCHOOL PROVIDING EDUCATION TO STUDENTS IN WESTMORELAND PARISH. WE PURCHASED FRESH FRUITS AND VEGETABLES THAT WERE DELIVERED TO THE ACADEMY’S CAFETERIA SO THAT IT CAN PROVIDE FRESH AND HOT FOOD FOR THOSE STUDENTS THAT ARE UNABLE TO AFFORD TO PURCHASE LUNCH.

POOR RELIEF, SCHOLARSHIPS, AND COMMUNITY DEVELOPMENT. EACH MONTH, APPROXIMATELY US\$50 IS GIVEN TO EACH OF SEVERAL RETIRED SENIOR CITIZENS WHO ARE IN POOR HEALTH AND UNABLE TO PAY FOR ADEQUATE MEDICAL TREATMENT. CURRENTLY, SIX PEOPLE (RANGING IN AGE FROM 68 TO 82) RECEIVE MONTHLY CHECKS, WHICH HELP WITH MEDICINES AND SPECIAL NEEDS. WE ALSO PROVIDED SOME ADDITIONAL FINANCIAL ASSISTANCE TO AN ELDERLY MAN WHO WAS HOSPITALIZED WE PAID FOR THE SCHOOL FEES, UNIFORM COSTS, AND SCHOOL BOOKS FOR AN ORPHAN, DAVIA KNIGHT, AS WELL AS ASSISTANCE TO A SECOND STUDENT WHOSE FATHER IS DECEASED. IN ADDITION, WE PAY FOR FOOD DISTRIBUTION AND HOST COMMUNITY GATHERINGS IN TWO COMMUNITIES THAT SUFFER FROM PERSISTENT POVERTY, AND WE SUPPORT A LOCAL ORGANIC FARMERS ORGANIZATION AND ANOTHER ORGANIZATION THAT PROTECTS MARINE HEALTH WE PAID FOR FENCING AND MAINTANCE OF A SPORTS FIELD AT MEARNSVILLE PRIMARY SCHOOL, AND STARTED WORK ON A PROJECT TO IMPROVE PLUMBING AT THE SCHOOL.
