Indonesia - Aceh Peace & Bus. Dev.
To see the people of Aceh enjoy an increasing quality of life having been equipped to help both themselves and their neighbors.
Mission is to channel resources to alleviate the suffering of the people of Aceh while emppowering local people to achieve sustainable community development. Aceh is the worst affected location as a result of the 2004 tsunami, with massive loss of life and destruction of infrastructure. The people of Aceh have also suffered during armed conflict that lasted more than 30 years.
Methodology includes establishing pilot projects of plantation and nurseries for cash crops and animal husbandry which are being used as showroom and training center for agricultural projects in neighboring villages. Serving 450 families, 2000 people.

Indonesia - The Source: Grant, Operation Ground Zero Phase II
The Source provides a venue for long term Ex-Pat workers to stay by helping to provide visas and other services. It also oversees the Ujung Karang, (Coral Reef) Conference Center on the island of Weh (Sabang), Sumatra. They have implemented disaster response training and provides a tangible community development to the people and government of Aceh. The Source also provides basic hygiene and sanitation training through the CWHL (Clean Water for Healthy Living) program to marginalized communities in Aceh and is an umbrella organization for an English language school.

Indonesia - Leadership and Advance Training: Grant
YSD held a leadership training retreat for 100 local leaders, expats and their families. This retreat is to assist in training and mentoring potential leaders in the areas of leadership and character development so that they can model these characteristics among their various communities. This helps them in their educational efforts amongst the Acehnese, both in the cities and in villages. This retreat encouraged the participants to develop their leadership skills, thus increasing the level of effectiveness in their own work in Aceh. YSD is investing for the future, that is the leaders that work directly with families, communities and other organizations in or beyond Aceh.
